Larry Nelson presented the Treasurer's Report which was accepted.

ACME Demonstration: Ron Day reported that there was a good turnout by the Club and the public. He expressed a thank you to those members who demonstrated.

Elections: The following people were nominated:

Any additional nominations were asked from the floor.

### 2010 SYMPOSIUM

Demonstrators for our next symposium will be Cindy Drozda, Stuart Batty and Rex Burningham. This is a very talented group of demonstrators and promises to be one of our best symposiums ever. The dates will be April 9, 10, 11, 2010, so reserve the dates now. Over the next couple of newsletters we will highlight each of these individuals. With two Bio' presented the last two months, this month we turn to:

● Stuart Batty - grew up in the city of Newcastle in northeast England. He began woodturning at age 10 and is a third generation woodturner. Under the expert tutelage of his father, Allan Batty an internationally recognized woodturner, Stuart learned to make spindles and a variety of other production turning articles. These techniques have been used and passed on through apprenticeships for centuries in Britain.

Stuart started working as a fulltime production woodturner and teacher in his father's woodturning studio at the age of sixteen. At nineteen he started working for Craft Supplies Ltd. in England, which was the largest woodturning supplier in the world.

During the six years he worked for Craft Supplies, Stuart was the company's in-house woodturning teacher and demonstrator. He also set up Craft Supplies first sawmill, and was in charge of importing over 300 exotic woods, which were sold around the world. Stuart also developed and tested woodturning tools for Robert Sorby who at the time was Craft Supplies Ltd. sister company.

Over the past twenty-seven years Stuart has taught over 3,000 amateur and professional woodturners. He has demonstrated and taught in twelve countries, including over 180 different American Association of Woodturning clubs across the USA.

Stuart's style of work is greatly influenced by his background as a spindle turner with precise cuts and sharp detail. He uses very simple tools and grinds to create his pieces. His work is "pure" lathe work, with no carving or surface texturing. Stuart's artwork has been sold through prestigious galleries across Europe and the USA. He also has artwork displayed in the permanent White House collection.

Stuart believes we have only tapped the possibilities of what can be made on a wood lathe and the only limiting factor for most woodturners is their skill level and imagination. With production woodturning as his background, Stuart's foundation in woodturning helped him develop the push cut style and other techniques like negative rake scraping. These techniques allowed him to produce very delicate high-end pieces for galleries.





Along with his brother Ed, Jim Helbling was introduced to woodturning while doing landscape work for Duncan. That was four years ago, at the time he joined the DWT's. During these years he is also grateful for woodturning advise given by Ron and Duey.

After sixteen years in construction work, Jim developed a specialty in landscaping. He has been in this business for twenty-five years.

Jim prefers to turn exotic wood. Items he enjoys making are pens and wine stoppers.

For recreation Jim likes to fish and hunt upland game. Della, his wife, makes afghans as a hobby. They have two children.






Bismarck High School Demonstration:







### **Duncan Warren**

January 17, 1922 - March 19, 2010 Founding Member of the Dakota Woodturners

# One of the good guys

Duncan Warren was a special person and definitely one of



the good guys. His passing on March 19<sup>th</sup> will leave a large void in our organization and he will be deeply and very much missed. Most of us know him mainly from our association with the Dakota Woodturners. Some

probably don't know about Duncan's many other gifts and achievements.

He started his career as a Vocational Agriculture teacher in Gackle and Hazen. He then worked with the USDA as a soil conservationist and then was the director of the Morton County Parks and Recreation Department. In addition to being a founding member of the Dakota Woodturners Chapter, Duncan also had many other hobbies such as hunting, fishing, photography, rock collecting and woodworking. He was active in numerous organizations and his church.

Duncan was probably most proud of his service to the country during World War II and his participation in the Battle of the Bulge, serving with General George Patton. He said he was especially pleased to have had the opportunity this past fall to make a trip to Washington, DC with the Roughrider Honor Flight, to view the World War II Memorial.

The formation of the DWT's Chapter, which he initiated, is also one of his proudest accomplishments. This was his dream, wanting the best organization to provide learning opportunities to its members. Having started his career as a teacher, he was always a teacher at heart as evidenced in his goal of providing instruction through holding public demonstrations, the annual woodturning symposium and making sure instruction was available anyone interested in and new to woodturning, especially students. In promoting the club and the craft he always stressed doing it safety. He knew the vitality of the club would be based on education, helping new members get started and helping existing members improve their woodturning skills.

#### 2010 Symposium—What to Bring

It is upon us again, the 2010 Dakota Woodturners Annual Hands-on Symposium. The symposium is a great opportunity to learn from others in the field and to hone our skills. In preparation for the symposium, each person should plan to bring the following items (if you have them and if you don't, not to worry we are a sharing group):

- Mini-lathe (drive center, live center & K/O bar) Lathe Stand
- Extension Cord (Power Stripe if you have one) Work Light (if you want)
- Scroll Jaw Chuck
- CA Glue & Accelerator
- Turning Tools\*
- Paper & Pens for taking notes

\* The basic turning tools any special tools will be identified with the outline for each project.

The following summarizes the items need for each project and the type of wood (please avoid bring in the exotics, due to potential allergies for some folks):

Cindy Drozda – Turning finials

- Wood blank to be supplied by demonstrator
- Tools Basic turning tools, include small spindle gouge
- Other –

#### Rex Burningham – Turning a Platter

- Wood Blank Any type of dry wood (5.5" square by 2" thick)
- Tools Basic turning tools
- Other A worm screw for your scroll jaw chuck or a screw chuck

**Stuart Batty** – The Six Cuts of a Spindle Gouge

- Wood Blank Approximately 3"x3"x5" (2 ea.) & 5"x5"x3" (1 ea.)
- Tools spindle gouge

As for the wood blanks, there will be some extras available and if you have extra bring them to share with others.

Kris Roberts showed a small bowl that blew apart while turning. The lesson is to be careful when turning spalted wood. There may be cracks. He showed some Easter eggs made from Badlands Cedar and also a turning chuck that help in turning eggs.

Sam Fears: Showed a large cherry vase. It has a nice orange tint to the wood. He also showed a large hollow form vase that is now a bowl because of a wide crack that developed in the wood.

Earl Setterlund showed a small segmented oak bowl with diamond shaped walnut as inlay.

Dave Krumwiede brought 10 inch, grinder type salt and pepper shakers of ambrosia maple with inlayed turquoise on the top.

Larry Nelson showed a Myrtle wood platter with a turquoise inlay. The inlay was highlighted with a thin strip of black.

Dolly Erickson showed a baby rattle out of pine. A slender apricot vase and a Russian olive vase.

John Boehm brought Easter eggs that were hand painted by Alice Berning.

Don Flath brought an unusual spalted birch box that had a sliced piece of pine cone inlayed in the lid. The cone was cut on the bottom, and soaked in CA glue to give it strength.

Alan Erickson showed an Oland tool which is used for hollow turning.

Bryce Hill brought some bottle stoppers that had North Dakota quarters inlayed into the top. The contrast between the Coco bolo and the silver was nicely done.

Weldee Baetsch brought a small thin walled elm bowl that was nicely proportioned. The pith was preserved and added to the design. He also showed a turned disk that had a calculator inserted into it.

Ron Day showed a stemmed vase with lid

and finial. He used turquoise inlay to fill in some of the gaps that developed in the wood.



# **Wood Working Tips**

Bryce Hill submitted the following tips to Sawdust & Shavings.

Slicker Surfaces with Wax Paper: Rubbing wax paper on your table saw, jointer, planer and your lathe beds will keep the surface smooth and rust free. It's a very good substitute for paste wax.

Tighter Threads for Smoother Turing: Not everyone that has a 1"x8 tpi headstock has this problem. However, should you experience this problem, here's a solution.

When threading the headstock, the headstock did not provide adequate metal to metal contact with the screw on chucks or face plates. Consequently they tended to wiggle a bit in use.

To correct this problem, wrap the headstock threads with plumber's Teflon tape. In addition to making a tighter fit, the tape lubricates the thread making it easier to remove the chuck.

## **Regular Meeting**

Regular Meeting: September 11, 2010

Not to be outdone by his lathe, he also showed two cherry bowls, one with turquoise dust filling in a crack, and two bird houses with a buckeye base and cherry top. The black lines in the buckeye made the houses stand out.

Dale Hurt showed a spalted birch bowl that the wood had "over spalted" and bordered on rotten. However, it still proved to be a nice figurative piece. He also brought a box elder winged bowl or butterfly bowl.

Ernie Oster also brought a bowl he made from the wood of Duncan's wood pile. It was a shallow maple burl bowl.

Gary Nagel showed a stamp holder that he made using pink ivory. He sprayed it with ultra violet spray to keep the color from changing. It was very well done. Another club member mentioned that Armorall can also be used as an ultra violet spray.

Dolly Peterson showed a cedar candle holder, also one made out of apple and a bottle stopper with the state quarter inlayed into the top.

Ron Day brought several vases. One had a black walnut base with an alder body. It was a very figurative piece. He also had a smaller vase from maple and a 10 inch black locust. He had some difficulty in hollowing that one because of the hardness of the wood.

## Dakota Woodturners Executive Board Meeting Minutes — August 10, 2010

Good News—Bad News. The good news is the attendance at the E-Board meeting was double that of last month, the bad news is two BOD members are not enough for a quorum, so no official business was conducted. Therefore no official E-Board minutes are available.

President Ron Day, Larry Nelson, Weldee Baetsch and Dennis Schwind were present at the meeting. Informal discussions were held on upcoming programs, Ornaments for October, Deep Hollowing in November and in December Dave Krumwiede will demonstrate wood burning. Weldee provided an update on the remodeling status of the BSC Vo-Tech building. remodeling, appointing a nominating committee. Ron reported Duey had set up the October 22-23rd special wood turning demonstration. Friday evening will be an introduction meeting and more details will be provided at the October meeting. Ron also reported one more turner was needed for the 2011 Symposium and a few names were discussed and Ron would be making some more contacts. The Elections are coming up and a nominating committee will be appointed to find candidates for Secretary, Treasurer and one member at-large.

#### Suggestions for Using CA Glue – Duey Marthaller

Here are a few suggestions that might help avoid some of the frustrations in using CA glue. \* Keep fresh air moving in your work area. Use a fan to blow the fumes away. Bring in outside air if possible.

\* Acetone will clean up dried glue. But, it will not just wipe it off. You have to soak it off. If you get some on your fingers, just pour some acetone in a small container and soak the tips of your figures in it for a short time.

\* Medium thin glue works for attaching blanks to glue blocks. In fact, I prefer it to the thick. Make small scratches in the surfaces with an awl before gluing together. Make the scratches start at the center and go to the edge. Spray accelerator on one surface and place glue on the other.

\* Bottle covers and tip caps can get caked with glue. To reduce this problem, do not put the cover back on the bottle right away after you use it. Leave it set open until you are done gluing. Then go back, wipe off the top, and place the tip cap on. Pete Holtus does this. If you know you have to use it again soon, leave the top off.

\* When the cover and tip cap get clogged with dried glue, remove and soak them in acetone for a few minutes. They will clean up like new.

\* Keep your supply of glue in a refrigerator to extend the shelf life.

\* Large repairs require a lot of glue. Do not spray accelerator on right away. Wait for a few minutes and you will reduce the chance of a white precipitate forming. In fact, if you can wait, do not use any accelerator.

\* A Richard Raffin book suggests spraying accelerator on the area to be fixed first, and then add sawdust and glue. I have not tried this.







was done at a future demonstration. He also showed a tail piece with the center removed. He said that this removes undue pressure on pen blanks. He also showed some bird houses that he has made out of box elder and mahogany. He is trying to miniaturize the bird house and has made one about 1 inch tall.

Dolly Erickson showed some small platters turned from cedar. She also showed some handles that she made for bar-b-cue grill tools. Gary Nagel showed a large platter made from elm. The platter was approximately 16" in diameter.

Al Braun passed around some pictures that showed ½ scale farm equipment made completely out of wood.

Gordy Issak turned some wood that he got from Duncan Warren's wood pile. He showed a heavily figured platter turned from spalted maple.

Sam Fears brought a large egg shaped vase turned from Aspen. Aspen is a very light wood with suttel grain patterns. He also showed a bowl turned from Russian olive with beads around the rim. He also showed the homemade tools that he uses to turn.

Dale Hurt brought a segmented walnut bowl. There were 32 pieces glued up to make the bowl. He also brought a chalice that he turned and then fumed in ammonia. The fuming blackened the oak wood giving it an aged appearance.

Dennis Schwind brought a 3 foot wooden column that he turned. He believes the wood is elm, and it was nicely figured and proportioned. Ideal for a plant stand. He also showed the steady rest that he made and attached to his lathe. The workmen ship was very good, but he said if he made another one he would put better wheels on it so it wouldn't mar the wood. The steady rest was made out of high density fiber board with oak slides and roller blade wheels.
