A move to approve the Secretary's

minutes for January was put forth by Stan Zalumskis and seconded by Steve Hamar. Motion passed.

Show and Share items were presented by Stan Zalumskis, Wayne Peterson, Steve Hamar, Larry Zubke, Dolly Erickson, Alan Welte, John Warren, Twig Zahn, Don Robison and Guy Otteson.

Steve Hamar bought some large slabs of Redwood from someone locally.

Steve Hamar reminded everyone that we need **A LOT** of tops to fill our jugs for the summer events. We only have about 2/3 of one jug and we need to have 2 full jugs.

This year's raffle activities will be starting soon, so start thinking about items you can make or have made that you could pledge/donate to the raffle. We start gathering pledges in March and need to have all pledges made before May. The actual items will ideally be given to Denise by the end of June so they can be displayed at Art in the Park and Capital A'Fair events.

E-Board Meeting

DWT E-Board minutes February 16, 2021

Called to order at 7:02 p.m.

John Warren moved to approve the secretary's minutes. Spud Gruman seconded and the motion passed.

There was no Treasurer's report.

The club received a letter regarding changes needed to our website.

The February general meeting was discussed and thought to be a very good presentation with quality video. Approximately 40 people attended by Zoom.

Educational Grant program will be promoted more in the upcoming year to encourage more applications for next year's grants. The website and AAW magazine show different events that grants can be used for.

Tool order – Spud sent in the latest tool order. He may be willing to send in another order later in the year as a lot of items were not available.

Tops are needed for the summer events.

The budget committee is still waiting for paperwork to be able to create the budget.

Spring Symposium – Mark indicated we will do as the monthly presentations being recorded and will be at no cost to the members. It is believed we can apply for a grant to cover half of one of the presenters.

The topic of membership dues came up. Members who paid dues in 2020 do not have to pay for 2021. Consensus was that people who hadn't paid in 2020 will have to pay dues for 2021.

E-Board Meeting Continued:

Art in the Park – there is a rumor that the location will be moved as Dykshorn Park will still be under construction in July. Susie Q's is closed and we would have to work out a demonstration location – probably with Dot Frank. An online search seems to indicate they are considering Centennial Park on the strip as the possible location.

The Dakota Council on the Arts 2022 Grant hasn't been applied for yet as they are changing their software and it won't be available to use until a couple of weeks before the application deadline. Everyone was asked to submit photos that might be submitted with the grant application. Pictures of people turning would be great.

Fall symposium was discussed. Should the format be online demo followed by hands on in small groups? When will we need to decide by? Will the contracts need exit clauses? There are many decisions to make.

Several board members mentioned that it would be helpful to have guides to the board positions. It would be helpful to have information on each positions responsibilities, deadlines, time sensitive items, etc.

There is no new information on a different meeting location.

Denise asked where the site is that the videos are posted to and was told DakotaWoodturners.com, however, that site was not available when someone attempted to log in to it. This is the site that we received a letter about needing changes to. Kirk will follow up on this.

Our Facebook page has 78 people, 88 likes/comments and 55 saw the pictures Dolly posted.

Meeting adjourned at 7:56 p.m.
