E-Board Meeting

March 16, 2021 at 7:00 PM Zoom Meeting

Meeting called to order at 7:07 p.m.

Attendees were: Spud, Kirk, Mark K, Mike O, John W, Kleber, Becky W and Denise

Spud moved to approve the February minutes with a seconded by Kleber. Motion passed.

Treasurer's report - \$20 membership received from Bill B. Files were updated per Mark K. and Spud needs to buy Quicken and get reimbursed from the club. Spud will also need to take the tax documents to the accountant, Neil Person. Taxes are due by May.

Correspondence – the club received an offer for a group pricing for Bucks tickets – no interest was expressed.

Old Business:

March meeting review – good content, technical issues. Mark thinks the technical issue has been determined. They will keep video to small increments in the future, especially if in high def. Ron working on voice overs now.

Art in the Park – we did not formally apply for a booth space. We were sent to a sub-committee to be juried. We should know by the end of the month or beginning of April what will happen. John proposed we make a decision – Mark K moved we won't be part of Art in the Park if we are charged for booth space with a second by John. Discussion led to the motion being withdrawn.

E-Board continued:

A new motion by Mark K that we don't pay for a booth space and that if offered a free space, that Kirk, the DWT President, can negotiate the terms of the booth space. John W seconded the motion and it passed.

Spring symposium – Michael Alguire will host the April event which will last 2 ½ hours. He will demonstrate the Wheel of Delicacy and will send a web link and handout. He charges \$400 – half of which will be covered by a grant from the ND Council of the Arts. Mark is working on Dennis Paulus and his acorns. Becky W will reach out to the media about possibly doing a story on the club/event.

Fall symposium – no details or dates yet, but leaning toward October.

Other – Spud brought up the job responsibilities again. Some board positions appear to have some written responsibilities – although their location is not known. It was suggested to ask Dolly to create a guide for the secretary of their job duties as she was secretary most recently and for a while.

New business:

Raffle – Denise will create a flyer to send to Mark K to distribute that will ask for pledges by the end of this month. She will also talk to Pat S. about holding the drawing at his home again this year. Discussion is leaning towards doing the drawing in September on the meeting date. Motion by Spud to change the drawing date to September 11, 2021, Mike Orgaard seconded the motion and it passed.

Capital Affair – will be the 1st weekend in August. Kleber will check on the site and make sure we have electricity

Replacement for Art in the Park – if we don't participate in Art in the Park this year, Buckstop Junction was suggested for an event. Looking at possible events there, there was minimal interest in pursuing this.

Presenters for next year's symposium – the grant software was changed and it didn't ask for presenter's names. They will look around for presenters, including Sally Ault. More of them are no longer traveling. The grant was submitted for pre-review.

Ownership of out URL for out website – Denise Schwind owns our RUL with Go Daddy. Todd was the web master and is supposed to talk to him about getting the rights to the URL. Mark suggests the rights should be with the President and transferred every two years with the change of president. Magic City indicated they needed action to reactivate the site. Denise has sent us the bill for the rights in the past and we have paid them with no trouble. The cost is approximately \$360/3 years and our name costs \$120 every 5 years or so.

Other – We can negotiate with BSC in August for September thru December meetings.

Meeting adjourned at 8:15 p.m.
